19 The District Attorney of San Luis Obispo County, California, hereby accuses the
20 above named defendant of the following criminal offenses:

21 Count 1

22 On or about December 31, 2018, in the County of San Luis Obispo, State of California, the
23 crime of Unlawful Sexual Intercourse in violation of PC261.5(c), a Felony, was committed
24 in that engaged in an act of unlawful sexual intercourse with Jenna Doe (DOB 4/24/02), a
25 minor, not the spouse of the defendant, the minor being more than three years younger
26 than the defendant.

1 NOTICE: Being charged with this criminal offense can result in mandatory pre-conviction
2 HIV/AIDS testing and disclosure of the results to a victim and the Chief Medical Officer of
3 the jail or prison facility where you are incarcerated pursuant to Penal Code Section
4 1524.1 and Health and Safety Code section 121055 following a probable cause hearing
5 resulting in a court order.

6 Count 2

7 On or between December 31, 2018 and April 23, 2019, in the County of San Luis Obispo,
8 State of California, the crime of Contact With Minor For Sexual Offense in violation of
9 PC288.3(a), a Felony, was committed in that TYLER DALE ANDREE did unlawfully
10 contact and communicate with a minor Jenna Doe (DOB 4/24/02) , knowing that Jenna
11 Doe (DOB 4/24/02) was a minor, with the intent to commit an offense specified in Penal
12 Code Section 207, 209, 261, 264.1, 273a, 286, 288, 288a, 288.2, 289, 311.1, 311.2, 311.4,
13 and 311.11 involving Jenna Doe (DOB 4/24/02) .

14 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
15 section 290. Willful failure to register is a crime.

16 Count 3

17 On or between September 1, 2020 and October 15, 2020, in the County of San Luis
18 Obispo, State of California, the crime of Contact With Minor For Sexual Offense in violation
19 of PC288.3(a), a Felony, was committed in that TYLER DALE ANDREE did unlawfully
20 contact and communicate with a minor Rose Doe (DOB 4/18/03), knowing that Rose (DOB
21 4/18/03) was a minor, with the intent to commit an offense specified in Penal Code Section
22 207, 209, 261, 264.1, 273a, 286, 288, 288a, 288.2, 289, 311.1, 311.2, 311.4, and 311.11
23 involving Rose (DOB 4/18/03).

24 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
25 section 290. Willful failure to register is a crime.

Count 4

On or between December 31, 2018 and April 23, 2019, in the County of San Luis Obispo, State of California, the crime of Child Molesting in violation of PC647.6(a)(1), a Misdemeanor, was committed in that TYLER DALE ANDREE did unlawfully annoy and molest a child, Jenna Doe (DOB 4/24/02), under the age of eighteen years.

NOTICE is hereby given that adjudication as a ward of the Court for this offense and a disposition to the California Youth Authority will require you to register pursuant to Section 290 of the Penal Code. Willful failure to register is a felony.

NOTICE: Conviction of this offense will require you to register pursuant to Penal Code section 290. Willful failure to register is a crime.

Count 5

On or between September 1, 2020 and October 15, 2020, in the County of San Luis Obispo, State of California, the crime of Child Molesting in violation of PC647.6(a)(1), a Misdemeanor, was committed in that TYLER DALE ANDREE did unlawfully annoy and molest a child, Rose Doe (DOB 4/18/03), under the age of eighteen years.

NOTICE is hereby given that adjudication as a ward of the Court for this offense and a disposition to the California Youth Authority will require you to register pursuant to Section 290 of the Penal Code. Willful failure to register is a felony.

NOTICE: Conviction of this offense will require you to register pursuant to Penal Code section 290. Willful failure to register is a crime.

1 All of which is contrary to the statute in such cases made and provided, and against
2 the peace and dignity of the People of the State of California.

3 I declare that an investigation has been conducted to determine if said Defendant(s)
4 did commit the stated crime, which reports are attached hereto and incorporated herein by
5 reference, and that the facts therein show probable cause that the said Defendant(s) did
6 commit the crime. Your declarant requests the issuance of a Warrant of Arrest either if
7 said Defendant(s) do not appear voluntarily in response to an appearance letter, or if no
8 appearance letter was issued.

9 **Discovery Request:** Pursuant to Penal Code Section 1054.5(b), the People are
10 hereby informally requesting that defense counsel provide discovery to the people as
11 required by Penal Code Section 1054.3.

13 declare under penalty of perjury that the foregoing is true and correct.
