Damages also inclusive of lost wages and housing. Violations of Mr. Lastra's rights under 42 U.S.C. section 1983 (Malicious prosecution, retaliatory prosecution, Monell Claim); Cal. Civ. Code section 52.1 (Intentional Infliction of Emotional Distress). Defamation, libel, slander, and other applicable torts and claims.

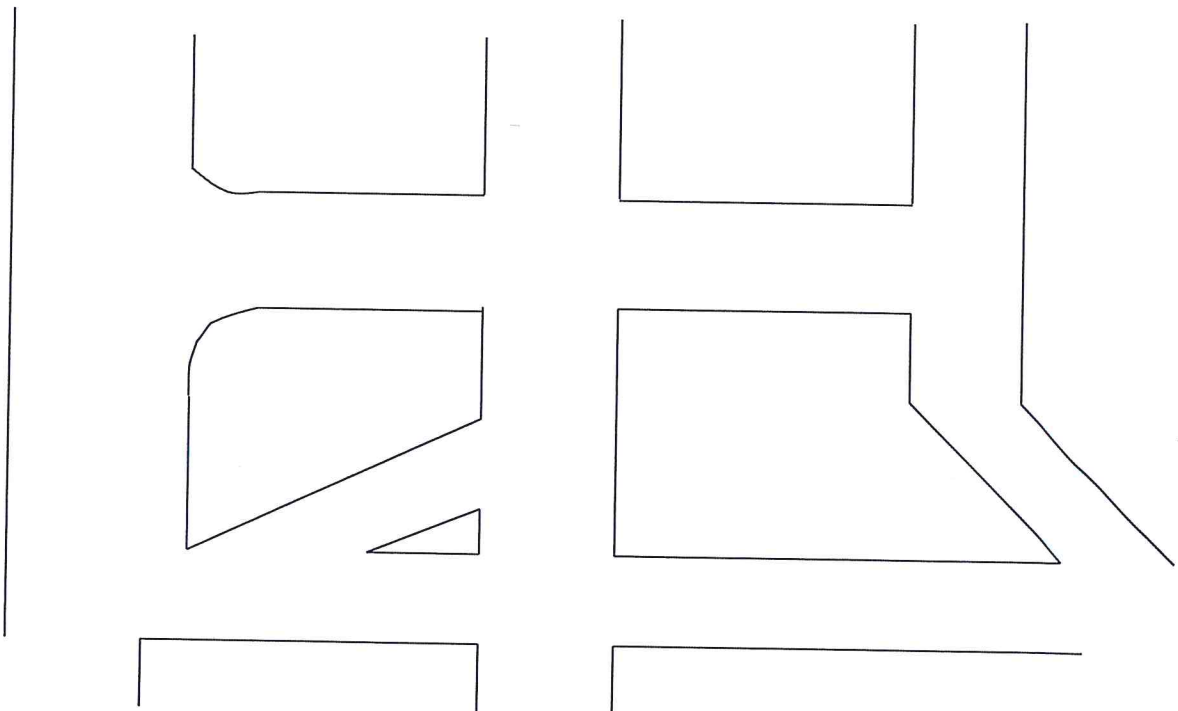
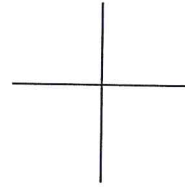

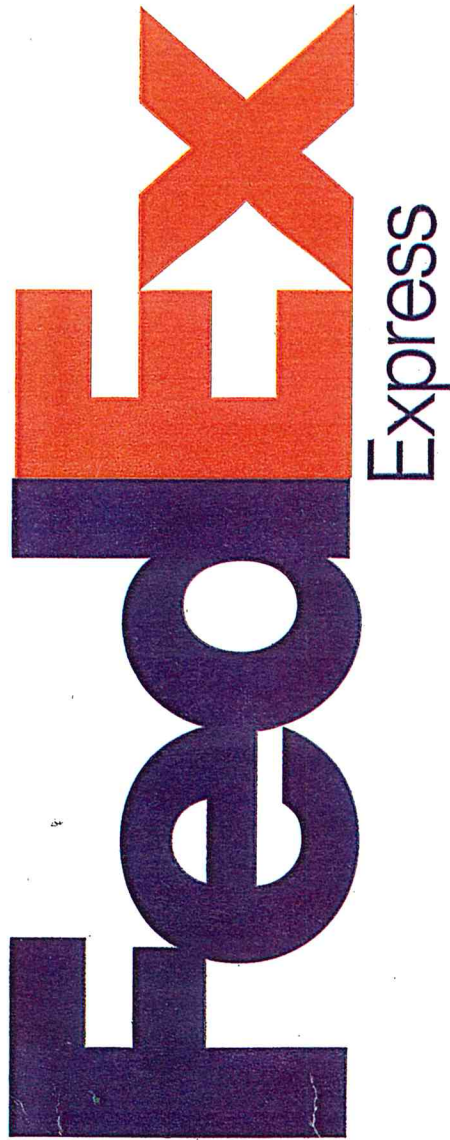
