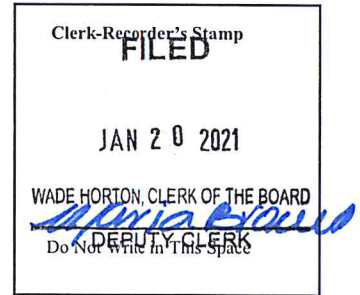

Violations of her civil rights under federal and state laws is alleged. DA Dow has defamed Arata, prosecuted her in an unlawful manner.
10. **Describe the Damage/Injury/Loss:** Arata has received death threats, loss of income, had her named defamed in the public, had to essentially hide and end her day to day existence based on the reckless, unlawful prosecution by the County of San Luis Obispo County. Violations of her rights under 42 U.S.C. Sec. 1983 (malicious prosecution; retaliatory prosecution; Monell Claim); Cal. Civ. Code Sec. 52.1; Intentional Infliction of Emotion Distress; Defamation and other applicable torts and claims.

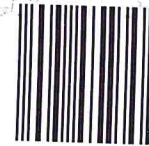
